### Narrative

Supplement report:

On Sunday 12/23/2012 at about 4:45pm, While I was working extra patrol for a Holiday Initiative, I responded to 9538 Kelsey Meadows Ct., Houston, Harris County, Texas in reference to an, "In Progress" call. It was being reported that there were two people that were hurt and possibly stabbed and one was possibly dead.

Upon arrival, I assisted deputies with clearing the rest of the residence and then securing the scene. I observed there to be EMS personal in the master bedroom bathroom attending to a female subject. I also observed a male subject in the master bedroom closet that was deceased. He was bound and was covered in blood. I then went outside to the frontyard and stationed Deputy Mccullough at the front door to start a crime scene log. I then assisted Deputy Amaya 4W71 with setting up crime scene tape around the frontyard area.

I then assisted with crime scene perimeter and securing some witnesses in patrol cars. I was later relieved by Lt. S. Jolly 8418 to return to working the Holiday Initiative.
