### Narrative

December 23, 2012

I, Cpl. E. Lopez 8494, was dispatched to 9538 Kelsey Meadows Ct in regards to a Priority One call. Upon arrival Dispatch updated the deputies enroute that someone was tied up.

Upon arrival I observed Deputy McCullough 4w18, Deputy McCants 4w13, and Deputy Dennis 4w23 inside securing the residence.

I observed a mop and a vacuum in the living room area. The master bedroom is in the north east area of the residence.

I observed a deceased nude male tied up inside the master bedroom closet near the bed. I observed a red color type rope around his chest and phone cord around his ankles. I observed a wound in his chest area.

A female was in the bathroom area of the master bedroom. I advised Deputy McCants to move her to the living room and secure the master bedroom.

I walked into the bathroom area. I observed the bath tub full with water and bowl of strawberries. I observed a butcher knife with a black handle inside the tube of water.

I instructed Deputy McCullough to keep a log at the front door and instructed Deputy Dennis to secure the master bedroom.

Deputy McCants had a Consent to Search Form signed by Sandra Melgar.

I observed the kitchen and found the knives to have black handles. I observed small pieces of paper that looked to be shredded from a paper shredder in the living room, and dining room. I was advised the shredded paper was in the master bedroom. I asked Deputy McCants to look in the vacuum for the paper. The vacuum has a see through clear plastic cover which allows you to look inside the vacuum without opening it. Deputy McCants stated
