I spoke with Benefits Manager B. Bailey, who advised Jaime Melgar had Life Insurance.

12:05 PM

I met with Carlos Espinosa, who was a friend of Jaime Melgar. He agreed to provide an audio-recorded statement at this location. Carlos Espinosa is employed with HISD and is assigned at this location.

12:13 PM

#### Witness statement of Carlos Joaquin Espinosa:

*Espinosa stated Jamie Melgar was a friend and coworker of his. Jaime Melgar was a positive person, and had no enemies. Espinosa stated Jaime Melgar's wife had a medical issue. He saw Jamie Melgar last on Wednesday December 19, 2012. Jamie Melgar took off early the week for vacation the week he was murdered. He stated Jaime Melgar was going to work on his house during his time off. Espinosa stated Jaime Melgar had no additional relationships, and had no issues with recent tenants of his rent homes.*

I downloaded the audio-recorded interview in the ARS document E-file.

I departed at 2:43 PM.

2:03 PM

I recovered the hard drive from the residence located at 9539 Kelsey Meadows, which was across the street from the scene location. The homeowner, Melaine Essman, stated person(s) from Sandra Melgar Attorney's Office arrived at her home and asked her if the camera recorded Sandra Melgar's garage door and she stated no. The camera at this home pointed down on the driveway.

**Investigative note:** During the interview, I asked Sandra Melgar a question in reference to the neighbor home video pointing at her home.

The security camera recorded the upper part of the driveway closes to the home.

I submitted the hard drives to Deputy Scott Williams.
