Your Affiant is Criminal Investigator Ronnie Odom of the Mississippi Attorney General's Office. Your Affiant is currently and has been a certified law enforcement officer with the State of Mississippi for more than 23 years and has an extensive background in conducting and supervising criminal investigations. He is employed as a Supervisor of the Insurance Integrity Enforcement Bureau, Mississippi Attorney General's Office and additionally conducts high-profile investigations assigned to the Public Integrity Division, Mississippi Attorney General's Office. He has have received training in the matter of Unresolved Death Investigations from the Institute of Police Technology and Management, is a Certified Fraud Examiner and holds a Bachelor of Science Degree from the University of Southern Mississippi in Criminal Justice with a minor in Forensic Science.

FACTS AND CIRCUMSTANCES

On February 26, 2014, Christian Andreacchio was found unresponsive and believed to be deceased at his residence, 801 Deer Run, Meridian, MS. Authorities were notified by a party present at the residence and emergency personnel were dispatched to the scene. Upon arrival of and examination of Christian Andreacchio by Coroner/Medical Examiner Marl Clayton Cobler, Andreacchio was pronounced dead having died from a single gunshot wound to the head. The Medical Examiner listed the death under section titles, “Accident, Suicide, Homicide, Pending Investigation, or Undetermined as ‘Undetermined.’” Parties present at the residence provided information indicating Andreacchio was believed to have died from a self-inflicted gunshot wound; however, circumstances and information described as suspicious and brought forth by other related parties have revealed matters that require further examination in order to corroborate or refute information gained during this investigation.

Therefore, your Affiant prays that a search and seizure warrant be issued authorizing with the proper assistance that AT&T Wireless, provides **Certified Copies** of:

- (7) Maps of cellular radio coverage (cell specific coverage) for the area of Meridian, Mississippi.**
- (8) A legend or glossary detailing terms and abbreviations used in responsive reports.**
- (9) Any additional data available from the AT&T Wireless SCAMP data system for the dates of February 20, 2014 thru February 27, 2014.**
